1. In view of the fact that after MAKSIM's^[i] departure we shall be deprived of liaison with the STORE [MAGAZIN]^[ii] and also of the [C% COMBINE's] [C% KOMBINAT[.AT]]^[iii] system of liaison with us for processing [OFORMLENIE] members of the TEN [DESyatKA] in CARTHAGE [KARFAGEN]^[iv] and BABYLON[VAVILON]^[v] in accordance with your instructions please sanction personal liaison between ANTON and the master [KhoZYAIN]^[vi] of the STORE [MAGAZIN]^[ii].

2. MAKSIM^[i] proposes to utilise TEACHER [UCHITEL'NITSA]^[a] for technical liaison with MAYOR [MER]. If you object [3 groups unrecovered] [C% NELLY [NELLI]] from DECREE [DEKRET]^[vii] to meet MAYOR [MER] meetings with him not [1 group unrecovered] through SERGEJ's wife^[viii] or LINA^[ix]. [b] Telegraph your decision.
